**14. OLD BUSINESS:**

- Swearing in Board members (Pete Carrao)
  - Scott Griffith conducted the swearing in of board member Pete Carrao

**15. NEW BUSINESS:**

- General Investment Allocation Policy
  - The finance committee is recommending a general investment allocation policy. They will meet a minimum of twice a year to review the chapter's net unrestricted assets to ensure it doesn't exceed two times the annual operating budget, and if it does, committee members will decide what to do with the extra money. PVA-WI would put this in place to build program sustainability without endowment to not have an excess of net unrestricted funds.

- Ken Matthews made a motion to approve the finance committee's recommendation for the general investment allocation policy. Angela Walker seconded the motion. All votes were accepted, no nays, no abstentions, and the motion was carried.
- Updates to Articles of Incorporation
  - Scott Griffith shared updating PVA-WI's Articles of Incorporation to restructure the wording to say to qualify as a full member for PVA-WI, you would simply need to be a permanently paralyzed veteran. PVA-WI would be removing the specific of spinal cord injury or disease. This would not make veterans a full member for PVA National, just the PVA-WI Chapter. We still need to get approval from the PVA National Executive Committee.
  - Ken Matthews made a motion to approve the update to PVA-WI's Articles of Incorporation to change PVA-WI's full membership qualifications to permanently paralyzed veterans. Michael Thomas seconded the motion. All votes were accepted, no nays, no abstentions, and the motion was carried.
- Move United Insurance
  - Scott Griffith reviewed the process of securing Move United as the insurer for adaptive sports coverage last year, after PVA National required all chapters to procure their own insurance in 2022. There has been a policy increase, which is standard across the insurance industry, the renewed policy will cost \$10,115.
  - Ken Matthews made a motion to approve the remaining with Move United as the PVA-WI insurer at the cost of \$10,115. Angela Walker seconded the motion. All votes were accepted, no nays, no abstentions, and the motion was carried.
